Brookhaven at Lexington COVID 19 Update 4 – March 17, 2020

The Commonwealth of Massachusetts updated state of emergency plans over the weekend. Governor Baker has restricted gatherings to a maximum of 25 and has closed all dine-in restaurants. Schools have been canceled.

In response please see Brookhaven Changes:

Continue to Wash your Hands with hot water and soap for at least 20 seconds frequently, and avoid touching your face. Please help to keep the Brookhaven Community safe for all Residents and Staff.

It is recommended that all Residents check their own temperature daily.

Resident Travel Upon return from domestic or international travel, Residents should stay in their apartments and call Resident Health. Resident Health will provide directions to resident.

Resident Health Department Residents are asked not to visit the Resident Health Suite until further notice. Resident Health Nurses and Aides will visit you in your unit. If you are sick, call Resident Health at 781-863-9660, x2370.

OSCO Deliveries Resident Health will deliver medications. Do not visit Resident Health to pick up medications.

Visitor Screening and Staff Screening has been implemented and will be fully operational on 3/18.



Limit unnecessary visits from families and friends if the visit is not essential to your health and wellbeing Brookhaven strongly discourages visitors.

Visiting Hours Visitors will only be allowed access to your unit during visiting hours – 10A to noon and 2P to 4P.

The Guest Suite is closed. There is no cot delivery.

Main Lobby Bridge Tables These tables will serve as waiting seats for visitors as part of the screening process and are no longer available for resident use.

Dining Services will continue to provide the dinner meal daily via take-out at scheduled times and locations.

Brookhaven Shopping trips are canceled. No shopping trips effective Wednesday, 3/18. Residents should Shop at Country Store. Family can drop groceries off on the cart at the Front Desk vestibule during Visiting Hours only (10-noon & 2 – 4)

Hair Dresser, Massage, Nails are cancelled effective Wednesday, 3/18.

Resident Group Sizes Maximum is 25. Residents must be spaced 6 feet apart.

Coffee Service Café Self-service has been replaced with Staff service only. Limited times of service will be posted.

To prevent cross contamination: All puzzle tables, boards and puzzles have been removed; Water Fountains are closed; and **The Library** will not accept book returns at this time .

Country Store Staff will operate the store in lieu of Resident Volunteers. Hours of Operations: Monday through Sunday from 10A to 2P.

Residents shopping at the store will be limited to two at one time. One resident can shop and one resident can check out.

Mail Cubby Room Only one resident at a time should be in the mail cubby room, due to the small space.
